DIRECTIONS FOR USE

Apply using a **PGS® 2000** wall dispenser or **PGS® 4000** wall support. Add a dose of product to the palm and add a little water. Rub both hands according to the hygienic hand-washing methodology.

The use of lukewarm water substantially improves cleaning. In the end, rinse with water until the product remains are removed and dry. Repeat the hygiene process when hands are visibly dirty.
