## DIRECTIONS FOR USE

Apply using **PGS<sup>®</sup> 350 Black Unitary** or in conjunction with other products using **PGS<sup>®</sup> 350 Black Double** or **Triple Black Line** exclusive wall supports.

Add one or two doses (3-6 ml) on the palm by pressing the dosing valve. Rub both hands previously wetted and rinse with water until removing product remains. At the end of the hygiene process, dry with a towel.
