DIRECTIONS FOR USE

Apply before sun exposure directly from the applicator tube or by PGS® 1000 wall dispenser.

Add the necessary amount of product to cover the entire area of skin to be protected and spread it evenly over all parts of the skin to be exposed to the sun, taking care not to leave any uncovered area.

Increase the frequency of application depending on the type, workload and exposure time.
