### **DIRECTIONS FOR USE**

Apply using a PGS® 2000 wall dispenser or PGS® 4000 wall support. Add a product dose to the palm and rub both according to the hygienic hand-washing methodology. The use of lukewarm water substantially improves cleaning. In the end, rinse with water until the product remains are removed and dry. Repeat the hygiene process when hands are visibly dirty.
