DIRECTIONS FOR USE

Apply directly or using PGS® 500 wall support or PGS® 1000 wall dispenser.

Add one dose (0,6 g) to the palm or skin area along with water. Rub both hands together and rinse with water until removing product remains. At the end of the hygiene process, dry with a towel or paper towel. Repeat the hygiene process when the hands are visibly dirty.
