DIRECTIONS FOR USE

Apply using **PGS[®] 350 Black Unitary** or in conjunction with other products using **PGS[®] 350 Black Double** or **Triple Black Line** exclusive wall supports.
After hair washing, add sufficient product to spread over the ends while they are still damp. Leave it on for two to five minutes and rinse with plenty of water until all remaining product is removed. At the end of the treatment, dry with a towel and comb.
