### DIRECTIONS FOR USE

Apply using **PGS® 350** and **PGS® 500** wall supports.  
After hair washing, add sufficient product amount to spread over the ends while they are still damp. Leave on for two to five minutes and rinse with plenty of water until all product remains are removed. At the end of the process, towel dry and comb through.
