DIRECTIONS FOR USE

Apply using **PGS[®] 350** and **PGS[®] 500** wall supports. Wet the hair and add two doses (6 g) of product to the hair. Rub the hair until the product is foaming and rinse with water until removing product remains. At the end of the hygiene process dry with towel.
