DIRECTIONS FOR USE

Apply using PGS® 500 wall support or PGS® 1000 mural dispenser. Hygienic skin cleansing: moisten the skin with drinking water and apply the desired amount of product. Rub the skin until generating foam and rinse with water until removing the product residues.

At the end of the hygienic process, dry with a towel or paper towel. Repeat the hygiene process as many times as necessary. Do not apply to intimate areas.
